4.	Hearing of appeals by the Chief Election Commissioner AJ&K at Muzaffarabad.	<u>27-07-2016</u> (From 10:00 a.m to 12:00 Noon)
5.	Decision thereon, in the Office of the Chief Election Commissioner AJ&K at Muzaffarabad.	<u>27-07-2016</u> (From 12:00 Noon to 4:00 p.m)
6.	Withdrawal of candidature.	<u>28-07-2016</u> (Before 12:00 Noon)
7.	Polling to be held in the Azad Jammu & Kashmir Legislative Assembly Lodging Hall MLA Hostel Muzaffarabad.	<u>29-07-2016</u> (From 9:00 a.m to 2:00 p.m)
